2. Old Business: The minutes of our last meeting were read and accepted

## 3. New Business

A. The board voted to raise 2008 ACWSA dues to \$15. Adjutant Gary Van Kauwenbergh recommended the increase because of an increase in the cost of insurance combined with a dip in membership. Last year our insurance company was bought by another company. Under the old policy, we were paid a set amount per member, but now we pay a set rate for a club with less than 500 members. With fewer members the higher cost needs to be spread among less people.

- 2. The 2nd WI would prefer to host a two-day skirmish at Stonebank on June 7-8, but will host a one-day musket/carbine team only event on June 14th if Stonebank is not available. Bristol is not available on June 7-8.
- 3. The 8th WI would prefer having their skirmish a week earlier. If the N-SSA doesn't schedule a skirmish on the immediately preceding weekend, they may change the date.
- C. Commander Chabalowski discussed purchasing a portable defibrillator for the ACWSA. Defibrillators cost approximately \$2000. Defibrillator batteries cost about \$60 and need occasional replacement. Paymaster Darlene Van Kauwenbergh reported we had about \$1,800 in

the treasury. Bob suggested we bring this back to our teams for discussion, and consider paying for one with a \$5 dues surcharge in 2009.

D. 8th WI Commander Dick Tessmann announced the location of their upcoming skirmish on labor Day Weekend was changed. The new location will be nearer to Rhinelander than Tomahawk.
